

10th Annual Run for the Mountain

On September 12th, the 10th annual *Run for the Mountain* took place at Westwood Lake. It was a perfect fall day, and 223 runners and walkers raised \$2,700 toward acquiring lands to add to the Mount Benson Regional Park.

This year was a year of firsts, as most winning runners in the six categories reached the podium for the first time. They were:

Emperor - Craig Odermatt 21:37 - 1st time Emperor

Empress - Victoria Fiddick 26:31 – 1st time Empress

King - Andrew Howard 21:21 – 1st time King

Queen - Melissa Ross 23:33 – 1st time Queen

Prince - Miles Huynh 22:03 - 1st time Prince

Princess - Madison Heisterman 25:07 - 3rd time Princess

In the team category, the Oceanside Track and Field team—with an average time of 23:54—took the crown. The team consisted of Miles Huynh (22:03), Yosef Bassett (24:04), Jackson Isnor (24:12), Linden Kaps (24:15) and Jacob Bassett (24:56).

This was also a year of lasts. After the event, founder Mike Thibodeau, who for the past 10 years has spent countless hours, organizing, cajoling, sweet-talking, glad-handing and promoting the run, announced this would be his last year. It has been amazing to assist Mike each year, as he began thinking about and planning the next race almost before the current year's run was over - innovating and growing the event to ensure participants' enjoyment, and to maximize the benefit for land protection. Through his efforts, the 10 years of runs have raised well over \$40,000 for the next phase of land acquisition on Mount Benson. Great job, Mike! Thank you.

World Rivers Day

Rivers Day has been observed annually on the last Sunday in September for almost 30 years. The celebration was begun by a Burnaby biologist and river-lover; and over the years it has expanded from being just a BC event, to become World Rivers Day. In Nanaimo this year, Rivers Day activities began on Friday, September 25th, and culminated on Sunday, September 27th with a celebration alongside the Millstone River in Bowen Park, hosted by the City of Nanaimo in partnership with NALT.

On Friday, September 25th, a nearly sold-out bus load of people joined representatives from the City of Nanaimo, Island Timberlands and TimberWest on a tour of the Nanaimo River Watershed—including the facilities of Nanaimo's drinking water reservoir at Jump Lake, as well as forestry practices within the greater Nanaimo River watershed. Participants also experienced an excellent display of problem-solving and professional driving skills by the bus driver.

On Rivers Day, many more folks took part in a number of other ½ day tours, including a guided hike through the Nanaimo River Regional Park, a bird-watching walk at the estuary, a raft tour of the estuary, and a visit to the Morden Colliery Mine site. After these tours, people were encouraged to come to Bowen Park to enjoy live entertainment, educational activities about the importance of rivers to our community and NALT's signature barbeque salmon burgers. Sunny weather, a scenic locale and great fun and food all contributed to make another successful Rivers Day.

Emerging as a keystone seasonal event, Rivers Day is beginning to catch on in the Nanaimo area. NALT will work with our partners in the Nanaimo River Watershed Roundtable and with the City to build on the success of this year, and increase community participation in next year's event.

Watch for it—always on the last Sunday of September—and tell your friends not to miss out.

The Bluebirds Are Back!

Exciting news for Bluebirds, and for the folks who love to sight these beautiful, birds with their vibrant plumage. Over the past four years, the Garry Oak Ecosystems Recovery Team (GOERT) have engaged in an ambitious campaign to re-populate the meadows of Vancouver Island with coastal Western Bluebirds—and, by all accounts, it seems to be working!

Since the 1970s, Western Bluebirds populations on Vancouver Island have been diminishing, and 20 years ago, they were considered extirpated in this area – along with other Garry Oak meadow bird populations, such as Meadow Larks and Vesper Sparrows. Some years ago, GOERT staff got news of a recovery program in Washington State that had restored a Bluebird population from just one nesting pair to 50 adult birds—and growing; also expanding north to the San Juan Islands. GOERT folks got in touch with the Washington restoration team, and they worked together to expand that program north to Vancouver Island and the BC Gulf Islands.

In the spring of 2012, GOERT and the Washington group began translocating nesting pairs and their fledging families to waiting nesting sites in the Cowichan Valley—initially located at a Garry Oak nature reserve, and, as the populations grew each year, expanding to neighbouring private rural properties, where rural residents were shown how to attract and care for the nesting birds

each year.

But the exciting part for Nanaimo and Ladysmith area residents is that, as populations have grown over the past four years, the returning birds have been expanding their territories from the first recovery site in the Cowichan Valley, some have been seen as far up the island as Cassidy the past two springs. If you live on rural property that features open meadow areas in the Cassidy/Cedar/Yellowpoint areas—or other adjacent neighbourhoods—get your nestboxes up and watch for the flash of a pair of Bluebirds next spring, or the one after. The male bird is the bright blue one; the female's plumage is a softer blue-grey.

If you sight a Bluebird anytime, anywhere, contact the Garry Oak Recovery Team and report your sighting, at bluebird@goert.ca

You can find countless accounts, personal stories, photos and videos on the GOERT website, as well as information about Bluebird nesting boxes, where to locate them to best attract a nesting pair—and everything you ever wanted to know about these beautiful birds. The male Bluebird in the photo by Chantel Jacques was spotted last spring near Old West Saanich Road, in Saanich. He was not banded, so was not part of the recovery program. Other un-banded Bluebirds are showing up on Vancouver Island and the Gulf Islands—sometime mating with banded recovery birds, and adding to the expanding population. Feature areas that NALT is or has been involved with—including the Linley Valley, Mount Benson (and views from), Harewood Plains, pretty much all the creeks and rivers (and their watersheds) in and around Nanaimo (with special emphasis right now on the Nanaimo River), Martha's Place in Qualicum Bay (now a NALT property), Hamilton Marsh, Moorecroft Park, the Yellowpoint Lodge property, the Parnassian Woods (Van Kerkoerle property in Cassidy), sites on Lasqueti Island, South Winchelsea Island, Gabriola Island and Mudge Island, plus local area parks where NALT has been involved with invasive species removal and habitat projects over the past 20 years. Also welcome are close-ups of local flora and fauna that are generally found throughout the Nanaimo region—and, although we generally do not use photos that *feature* people or pets, "fauna" may include outdoor hikers, paddlers or other recreation-lovers. A figure in the background can enhance a scene or setting, or add context to the "story".

If you have a great photo of some site or feature that we may have missed on this list, send it in for consideration.

How to participate?

Please share with NALT your special photos that depict the natural beauty that makes this area such a great place to live. For photos to be considered for the calendar, they need to be shot in landscape (wide, not tall) and in a high enough resolution for clarity when they are enlarged to the calendar size of 81/2" x11" (3+ MB is usually good). Photographers whose images are chosen for the calendar will receive five free copies of the calendar in which they are used. As you may have noticed, each year we try to select a balance of images and match them with an appropriate calendar month or season; so, if one of your photos is not selected the first year that you submit it, we will keep all un-used submissions on file, and may use one or another for a future calendar.

Your photos may also be used for other NALT fundraising items (such as note cards, postcards and posters). You will be notified whenever we do use one of your photos, and you will receive recognition each and every time your photos are used.

Life Insurance and Charitable Giving: Another Way to Support Your Favourite Charity

It is a fact.

Canadians are passionate about supporting causes that matter to them. The latest report from Statistics Canada indicates that 94% of Canadians, aged 15 or over, gave goods or food, or made a financial donation in 2010. The same study also reports that as Canadians get older, they give more. On average, people between ages 55 – 64 give \$52 per month and those age 75 and over give \$60 per month. But what if we can find a way to convert this average annual gift to \$35,000 for your favourite charity? The answer is life insurance.

How does it work?

There are three main ways in which a donor can gift life insurance to a charity:

- Bequest of a life insurance policy through his or her will
- Donate a policy during his or her lifetime
- Name charity as beneficiary of the policy

Beguests of Life Insurance through a Will

The donor owns the policy during his or her lifetime and the estate is the beneficiary of the policy proceeds. The donor's will indicates the amount of the life insurance proceeds that will be donated to the charity. The charity receives a lump sum of money from his or her estate upon the donor's passing. The donor will not receive tax credits for the premiums paid, but new rules for deaths occurring after January 1st, 2016 will allow certain estates ("Graduated Rate Estates") to allocate the donation on either of the following:

- The taxation year in which the donation is made, or any of the subsequent five taxation years.
- The last two taxation years of the deceased donor, to a maximum of 100% of net income.

The biggest advantage of this type of bequest is the donor retains full control over the policy until his or her passing. A perceived disadvantage of this approach is the life insurance proceeds may be subject to probate fees, creditor claims and estate litigation. Probate fees in BC are applicable to estate values over \$25,000 at a rate of 0.60% up to \$50,000 and 1.40% of any amount exceeding this threshold.

Donation of a Life Insurance Policy While Still Living

This approach consists in transferring ownership of an already existing Life Insurance Policy to a charity and naming the charity as the beneficiary at the same time, while the donor will remain as the life insured. The following discussion would also apply to a brand new policy purchased by the charity on the life of the donor and for which the donor will make premium payments.

The premiums paid by the donor will be considered a charitable donation—making them eligible for a charitable tax credit. The donor may also be entitled to charitable tax credits if the existing policy being transferred has accumulated cash values, these credits will reduce the impact of potential deemed taxable gains upon the transfer of the policy.

No tax credits will be available upon the donor's passing for the life insurance proceeds received by the charity. The policy proceeds will not be part of the donor's estate.

Naming the Charity as Beneficiary of a Life Insurance Policy

The donor will not qualify for charitable donation tax credits for premiums paid during his or her lifetime. However, the donor may claim these tax credits on his or her final tax return for the life insurance proceeds paid to the charity. These tax credits may be carried back one year and be used against 100% of the donor's net income.

This alternative provides flexibility to the donor in the event that he or she no longer wishes to support the named charity. It also allows the death benefit to bypass the estate, resulting in savings while keeping these proceeds out of any creditors' claims (in most cases).
