

## World Rivers Day

Rivers Day has been observed annually on the last Sunday in September for almost 30 years. The celebration was begun by a Burnaby biologist and river-lover named Mark Angelo; and over the years it has expanded from being just a BC event, to become World Rivers Day. In Nanaimo this year, Rivers Day was on Sunday, September 25<sup>th</sup> with a celebration alongside the Millstone River in Bowen Park hosted by the City of Nanaimo in partnership with NALT.

The celebrations actually began on Friday, September 23<sup>rd</sup>, as a bus-load of people joined staff from the City of Nanaimo, Island Timberlands and TimberWest on a tour of the Nanaimo River Watershed—including of Nanaimo's drinking water reservoir at Jump Lake and a tour of the new, state-of-the-art water treatment plant on South Forks Road, as well as forestry practices within the greater Nanaimo River watershed. For the third year, this day-long tour was well-attended, and reports afterwards were enthusiastic!

On the morning of actual Rivers Day, more folks took part in a number of half-day tours, including a bird-watching walk at the estuary and a rafting tour of the lower reaches of the river and the estuary. Following these tours, people were encouraged to join the City and NALT at the lower picnic shelter in Bowen Park—to enjoy live local music, a guided walk of the Millstone River, other educational activities about the Importance of rivers to our community, and NALT's signature BBQ salmon burgers. Cooperative weather, a scenic setting, assorted activities for all ages, and great food all contributed to make a successful, family-oriented Rivers Day in Nanaimo. It is impressive to think about similar celebrations all happening on the same day around the world!

## 2018 Calendar Photos Now Being Collected

We love to receive photos that depict any or all of the four seasons in the Nanaimo area; and we love to fill our file of possible photos for next year's calendar *early*—rather than at the last moment! So why not send us up to 5 of your recent—or not so recent—photos now? Even if your photo doesn't make it into the 2018 calendar, it may be used by NALT, with your permission, in other ways: such as notecards, newsletter photos, posters, or a future calendar. And the credit will always be yours.

#### Here's what we are looking for:

Feature areas that NALT is or has been involved with—including the Linley Valley, Mount Benson (and views from), Harewood Plains, pretty much all the creeks and rivers (and their watersheds) in and around Nanaimo (with special emphasis right now on the Nanaimo River), Martha's Place in Qualicum Bay (now a NALT property), Hamilton Marsh, Moorecroft Park, the Yellowpoint Lodge property, the Parnassian Woods (Van Kerkoerle property in Cassidy, now gifted to NALT), sites on Lasqueti Island, South Winchelsea Island, Gabriola Island and Mudge Island, plus local area parks where NALT has been involved with invasive species removal and habitat projects over the past 21 years. Also welcome: close-ups of local flora and fauna that are generally found throughout the Nanaimo region. And, although we generally do not use photos that *feature* people or pets, "fauna" may include outdoor hikers, paddlers or other recreation-lovers. A figure in the background can enhance a scene or setting, or add context to the "story". If you have a great photo of some site or feature that we missed on this list, send it to us for consideration.

#### How to participate:

Please send us up to 5 of your special photos that portray the natural qualities that make this part of the world such a great place to live. For photos to be considered for the calendar, they must be shot in landscape format (wide, not tall) and in a high enough resolution for clarity when they are enlarged to the calendar size of 81/2" x11" (3+ MB is usually good). Please email your photos to <a href="mailto:paul@nalt.bc.ca">paul@nalt.bc.ca</a> or drop off a digital copy at the NALT office.

#### What's in it for you?

Photographers whose images are chosen for the calendar will receive 5 free copies of the calendar in which they are used. As you may have noticed, each year we try to select a balance of images and match them to an appropriate calendar month or season; so, if one of your photos is not used the first year that you submit it, don't be discouraged; we keep all un-used submissions on file, and may use yours for a future calendar. If the resolution of a photo is not high enough for use in the calendar, we may still use it in popular notecards that are available for sale all year round.
