Notice of NALT EGM October 23rd, 2019

On the afternoon of **October 23rd, 2019**, at **#8 – 140 Wallace Street** (the NALT office) the Nanaimo & Area Land Trust will hold an Extraordinary General Meeting (EGM). The meeting will commence at **4:45pm** and should be concluded by 5 pm. The sole purpose of this meeting is to approve a couple of amendments to NALT's bylaws to complete our compliance with both the new Societies Act of BC and the charity status requirements of the Canada Revenue Agency (CRA).

The resolutions read:

Resolution #1

Be it resolved that the NALT bylaws be amended to replace its current dissolution bylaw, Part 15, with:

In the event of dissolution of the Society, after payment of all outstanding expenses, liabilities and debts, NALT shall distribute or dispose of its remaining property to qualified donees as described in subsection 149.1 (1) of the Income Tax Act

Resolution #2

Be it resolved that a new Part be added to the bylaws to read:

Part 16. The organization will be carried on without the purpose of gain for its members, and any profits or other gains to the organization shall be used in promoting its purposes.

These resolutions are required by the CRA and are recommended by the NALT Board of Directors.

For the purpose of the EGM, a quorum is achieved by the attendance of more than 50% of the Board of Directors. All members in good standing are welcome to participate in the EGM.

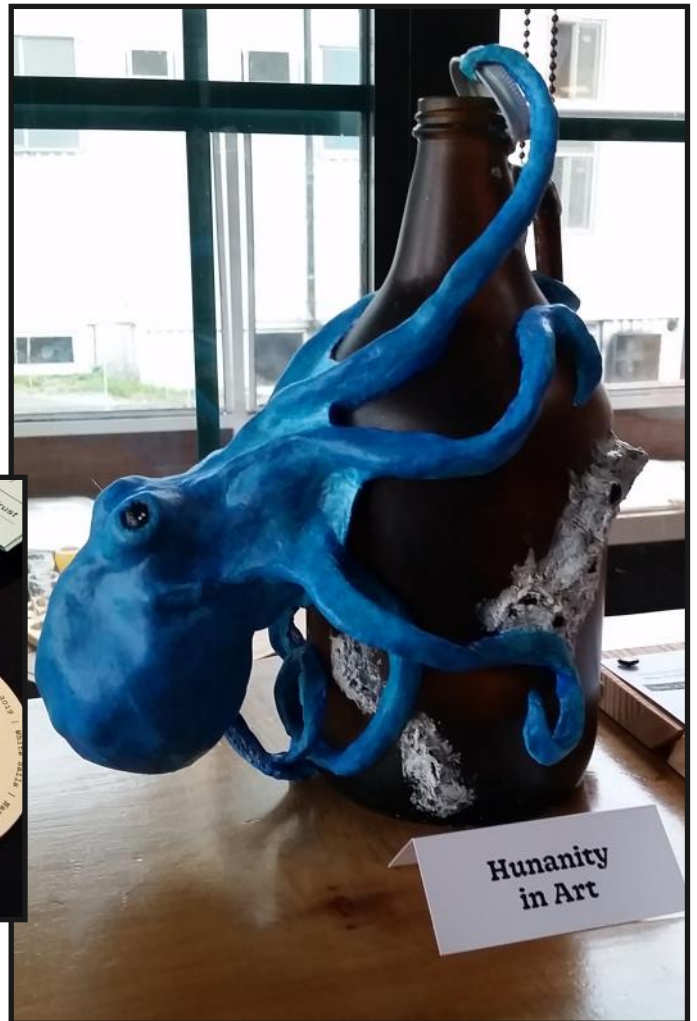
Sebastian and Brian took care of all the details and on Saturday, August 10th, folks gathered at the White Sails taproom to raise a glass and raise some funds.

The 17 percent solution

So here's a modest proposal. What if everyone in Nanaimo set a target of turning 17 percent of wherever they live back to nature?

Seventeen percent seems an odd number, but that's the goal Canada has set as the amount of land we should be protecting in a wild, natural state by 2020.

Seventeen percent doesn't sound like much, and there are very credible people who would tell you the goal should be much higher. But it's a start, and bear in mind that in the Regional District of Nanaimo, only about three percent of the land base is protected in a wild state while, nationally, the figure is just under 12 percent.

Achieving the goal where we live is particularly important. British Columbia has the most biodiversity of all of Canada's provinces, with at least 143 mammals, 454 bird species, 20 amphibians, 19 reptiles, and nearly 3,000 vascular plants. Southern Vancouver Island, with its warm temperatures and diverse geography, is one of the province's biodiversity hot spots presenting those of us who live here with a particular privilege, and challenge, of co-existing with wild natural abundance.

The Nanaimo and Area Land Trust (NALT) is dedicated to that abundance, having already protected nearly 900 hectares of land through direct acquisition or conservation covenants with private landowners. But beyond supporting NALT, what can you do?

Back to that modest proposal. If you've ever taken a summer's walk through parts of Nanaimo where empty lots alternate with neatly kept properties – Kennedy Street is a good example – you'd notice the manicured properties are silent while the empty, abandoned to native and naturalized plants and all the bugs and birds they attract, are literally buzzing with life.

We're not suggesting you give up on maintaining your property, but we do propose (that word again) that you dedicate a modest 17 percent portion of your outdoor space – be it a balcony or an estate – to native plants.

Why native plants, specifically, rather than pretty perennials?

While some non-native perennials do attract pollinator insects, plants native to southern Vancouver Island have spent many, many millennia co-evolving with the island's insect, bird, mammal, and marine species forming an intricate and irreplaceable web of biodiversity and abundance.

There are a couple of ways to approach rewilding a portion of your outdoor space in support of that web. One way is to regularly visit NALT's Natural Abundance Plant nursery at 3145 Frost Road in Cassidy, talk to the experts there, and bring home some native plants. Another approach, if you have a larger, more mature property, is to learn to identify the native plants that may 'volunteer' themselves – Oregon grape, thimbleberry, trailing blackberry, and salmonberry come to mind – and simply let them do their thing as you remove non-native species, particularly those that can be invasive. Or use both approaches at the same time.

To learn more, please mark Saturday, November 16th, on your calendar. That's when Pacific Gardens Cohousing will host a planting and workshop day in conjunction with NALT, the Regional District of Nanaimo, and Alder Environmental. Events will include presentations on native plants and their role in watershed stewardship, as well as an opportunity to get your hands dirty planting native species to support a wetland on the Pacific Gardens property. Activities start at 10 a.m. Pacific Gardens is located at 347 7th Street.

It's been a few years since NALT has launched a membership drive, it is time to do it again!

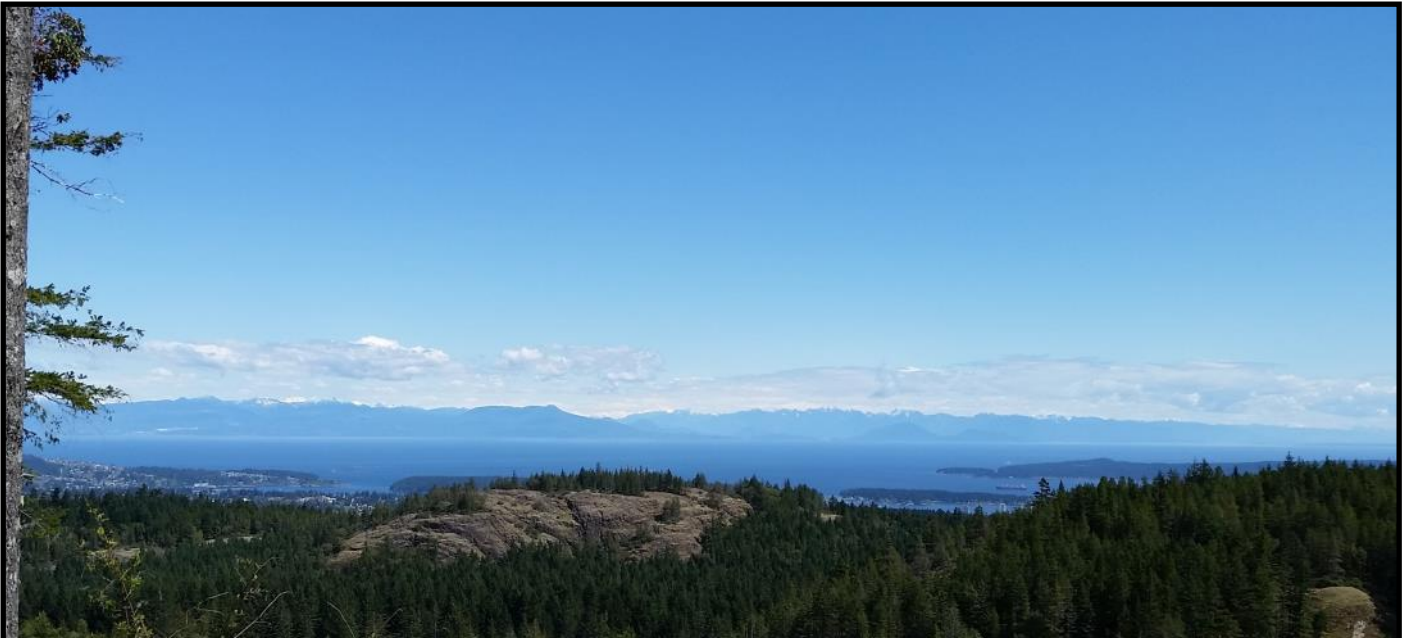

Conservation Covenant Annual Monitoring

Conservation covenants are legally binding agreements held on land titles that follow the succession of owners, protecting land from development in perpetuity and maintaining integrity of the land's natural values. Conservation covenants have proven to be one of the most effective means NALT has to protect natural values on both private and public land. From our first foray into the world of conservation covenants in 1996 to our latest in the spring of 2019, with the support of our conservation partners who act as co-holders of our covenants and generous and caring landowners, NALT has helped to secure well over a thousand acres of land and ecosystem function in perpetuity.

Annual monitoring is an essential element to ensure conservation agreements are upheld. Activities within a covenant that are generally restricted include removal of native plants, planting of non-indigenous species, development, dumping of refuse, use of herbicides or pesticides, camping, fires as well as hunting, typically with exception to First Nations leading traditional practices. Parameters a covenant holder will look for while conducting an annual monitoring visit are any signs of trespass that may impact its environment, interference with hydrology, pollution, changes in climate and ecology. Notes of interest also comprise the diversities of rare and endangered flora and fauna living within a conservation covenant.

Visits take place in the spring while the wildflowers are in bloom, and discovery of rare flora has maximum potential. While some of our protected lands are open to the public, others are best left to flourish on their own. NALT helps to protect over 486 hectares of wild land through conservation covenants in the Nanaimo region including three Gulf Islands.

NURSERY NEWS

It's nearly fall again, after a beautiful summer. In this season of mists and mellow fruitfulness, our NALT Nursery has a *Natural Abundance* of native plants. Fall is a great time to plant herbaceous perennials, shrubs, and potted trees. Planting in the fall ensures plants have a chance to establish roots in the moist soil before winter freezes.

We have about 100 varieties of plants, a little bit of a lot of things! We have 40 varieties of native seeds for sale. These seeds are best planted in spring or fall. We're open Wednesdays 10 – 3 and Saturdays 11 – 3 year round, and we hope you'll visit, even for a look around. And yes, the elk are still residing on the Van Kerkoerle property. We're always thrilled to catch a glimpse.

What's old is new again. Brian from Osprey Electric diagnosed and repaired our solar system that has been on the fritz for nearly a year. Thank you, Brian! We are glad to be able to provide the growing plants and nursery volunteers with fans, roof collected water, and lights.

Colleen Rohde generously offered to sell her garden lilies as a fundraiser for the nursery. She sold her beautiful lilies at the last Bottle Drive and at her home the following weekend. Thank you, Colleen!

The native plant nursery will be part of **Rivers Day Sunday, September 22, at Mafeo Sutton Park.** Although we'll bring just a sampling of fall plants, you could contact us if you are interested in seeing a particular plant at the NALT Nursery display table. This year we'll feature native planters that could be a lovely part of a fall garden display.

This autumn season begins our major salvaging and propagating work. Please contact Susan at plants@nalt.bc.ca if you're interested in volunteering for planting seeds, semi-hardwood and hardwood cutting propagation, or salvaging.

We'll begin digging trees from the ground when it's colder and dormancy has set in, typically around the end of October. And – yes, NALT will again sell or rent potted trees for Christmas, along with the popular native seed packets.

Ever wonder what makes a native a native?? They're plants that have thrived in our Pacific Coastal Region ecosystem since before European influence. They have evolved along with local birds, butterflies, insects, animals, even local soil, so they are "naturals." It follows that our native plants are disease resistant and drought tolerant, living among their long time companions. Our more specific local ecosystem is the Nanaimo Lowlands, which is unique with Garry oak meadows and Douglas fir systems, as well as many hearty native plants.

"RESPONSIBLE HIKING" VIDEO IN PRODUCTION

This year NALT received funding to produce a hiking video focusing on ecology, etiquette and safety. It's being created as part of the Job Creation Partnership, which provides meaningful job experience and community contacts for participants. The project team includes two participants and one project coordinator.

The final 15-20 minute video will be used by stakeholders in our community (and beyond) like school groups, hiking clubs, Search and Rescue (SAR) groups and naturalists to spread the message of responsible hiking. We hope the video will also increase stewardship and appreciation of natural spaces.

The project began in May with research. We familiarized ourselves with regional trails, completed hikes, spoke with trail users and scouted for future shoot locations. It's a tough job, but someone's got to do it!

The team identified key issues related to the video's topics of ecology, etiquette and safety. We practiced using our camcorder, audio and lighting equipment and brushed up on our interview skills.

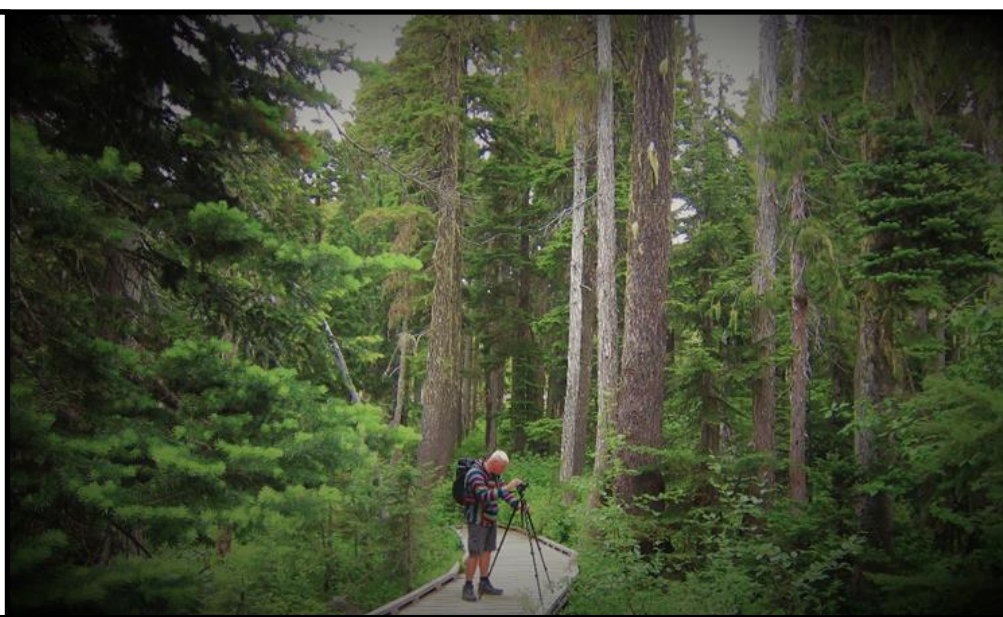
Next, we reached out to a variety of trail users and professionals to interview, including hikers, mountaineers, a naturalist, trail runners, mountain bikers, and members of WildSafeBC, Nanaimo SAR and Strathcona Wilderness Institute. We've met some fascinating people to feature in the video who'll share their passion about the trails.

In September, we're finalizing the script for our video hosts, and tying the information, interviews and footage together. Time is moving quickly, and our deadline is approaching!

This is a great project to work on. All three team members have said (numerous times since the start of the project); 'this is the best job ever!' We're all looking forward to screening the final video in early 2020.
